Please Note

In recent years we have seen an increase in the number of participants in our concrete programs. This has been great to see; however, there are limits to the number of cylinders LabSmart can produce for a single program (without compromising the quality of our samples). Due to this factor, we are currently limiting the number of participants for this program to around 50. This is not a hard limit; it could be more or less depending on the quality of the finished concrete.

To counter this, we have started running more concrete programs within the year, and depending on demand for this program, we could run two or more groupings.

We fully intend to accept all participants that apply to this program. However, for various reasons (including the ones listed above), we may need to roll some participants into our next Concrete Proficiency Program. To make your transition seamless, the 'Order Form' will ask you to confirm that (if needed) you would like to be automatically rolled into our next scheduled concrete program (the next expected concrete program would be around October 2024). If this were to happen, you would be notified, and you will have your price locked into the price listed on your order form.
